- · a subject of Bhutan, or
- a Tibetan refugee who came over to India, before 01.01.1962 with the intention of permanently settling in India, or
- a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African Countries of Kenya, Uganda, the United Republic of Tanzania, Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India.

Provided that you belong to the above-mentioned last four categories, you must possess a certificate of eligibility issued by the Government of India.
